## CORPORATE PARTIAL SCHOLARSHIPS FOR SACYR EMPLOYEES

**IE offers a Corporate Partial Scholarships program for CEPSA employees** (including employees of any of its affiliates, subsidiaries or related companies) for its various executive education programs until July 2021.

## Eligibility requirements and terms and conditions of IE's Corporate Partial Scholarships for CEPSA employees:

- Candidates for these **Corporate Scholarships** must have been employed or under contract by **CEPSA** or one of its affiliates or subsidiaries for at least six (6) months prior to beginning the admissions process for the corresponding program, have successfully applied to **IE**, and have been accepted to the corresponding program.
- The award of the Corporate Partial Scholarship will be at the complete discretion of IE, which
  reserves the right not to award it should it consider, on justified grounds, that the candidate's
  profile and/or performance in the admissions process do not meet the minimum standards for its
  award.
- The Corporate Partial Scholarships will apply solely to those programs determined by IE. The
  amount of the scholarship will depend on the type and category of the chosen program and will
  at all times be subject to the availability of places in the program in question. For all the details
  of programs to which the Corporate Partial Scholarships apply, refer to your Human Resources
  Department.
- To determine the amount of the **Corporate Partial Scholarship** for each program, the information request form must be sent through the "IE Learning Hub" platform that CEPSA has included in its intranet.
- **Corporate Partial Scholarships** will apply solely and exclusively to the tuition fees in force for the program for the 2019/2020 and 2020/2021 academic years. They do not apply to any other items. Should a candidate qualify for multiple benefits, the largest one will be applied.
- A **Corporate Partial Scholarship** awarded to a specific employee will be non-transferrable.
